Declaration of vacancy on Township Board

Joe Kral, Frankfort Township Assessor, announced that the time for soft appeals has officially started and will continue until June 1st. Home sales are up and there is resurgence in commercial building and permits. He explained how the appeal process works and how to use the Frankfort Township Assessor’s web site.

Jim Moustis, Frankfort Township Supervisor, reported that the Frankfort Township Charities Foundation is looking for board members. The Foundation will be able to provide further assistance to people in distress beyond the basic services offered by the food pantry.
