Highway Department 2024-2025 Salt Purchase Approval

Highway Commissioner Bill Carlson described in detailed the new process and paperwork required from the state for salt procurement. The Highway Department filled out an electronic form that requires a Certificate of Authority. Procurement is a multi-agency bidding process with the source being the State of Illinois. The Township Board will annually need to provide this Certificate as part of the procurement process. Document is attached.
